# **Executive Summary**

- 1. Advice on Council's Court proceedings for the period 1 December 2020 to 31 January 2021 is contained within this report.
- 2. Total legal costs to date for the 2020/21 financial year are \$1,159,364.00.
- 3. Total legal costs recovered to date for the 2020/21 financial year are \$122,675.00.
- 4. Total costs incurred by Council in legal proceedings are \$858,645.00.
- 5. Total nett costs are \$1,036,689.00.
