Thank you for your letter of 27 October 2021 requesting the Department of Infrastructure, Transport, Regional Development and Communications' (the Department's) comments on the draft Hurstville Civic Precinct Planning Proposal (the Proposal) and associated proposed changes to the Hurstville Local Environment Plan (LEP) 2021. I apologise for the delay in replying.

I am informed that Council has also consulted Sydney Airport Corporation Limited (SACL) on the Proposal and that the Obstacle Limitation Surface (OLS) and Australian Noise Exposure Forecast (ANEF) maps for Sydney Airport were considered in the preparation of the draft LEP.

As you would be aware, the *Airports Act 1996* (the Act) and the Airports (Protection of Airspace) Regulations 1996 (the Regulations) establishes a framework for the protection of airspace at and around the Federal Leased Airports. Construction activity that would result in an intrusion into the OLS constitutes a controlled activity under the Act. Controlled activities cannot be carried out without prior approval from the Department of Infrastructure, Transport, Regional Development and Communications. Details of any potential controlled activities expected for the Proposal, including the type and anticipated timing of the controlled activity, should be identified and assessed to ensure they do not adversely impact on the safety, efficiency or regularity of future aircraft operations into and out of Sydney Airport.

Please be advised, based on the information provided, the proposed change to the LEP to allow a maximum permissible building height (up to 60m maximum) for the proposed Hurstville Civic Precinct site does not appear to result in penetrations of prescribed airspace for Sydney Airport however, this will need to be verified with SACL. Also, while the proposed buildings may not intrude into prescribed airspace for Sydney Airport, construction equipment such as cranes may be required to operate at a height significantly higher than 60m therefore approval must be sought under the Regulations for any construction equipment (i.e. cranes) that will intrude into prescribed airspace.

Please note that applications for controlled activities are subject to rigorous assessment processes that are separate and in addition to development approvals issued by the State or Local governments. The Act and Regulations are administered by the Australian Government's Department of Infrastructure, Transport, Regional Development and Communications; decisions under the Regulations may only be issued by an authorised delegate and should not be pre-empted.

The Department encourages early engagement and consideration of controlled activity applications with the relevant airport, where possible. 


